CONTEST RULES "NEW ARTISTS 2021"

CERVEIRA ART BIENNIAL FOUNDATION, P.F.

PREAMBLE

The Cerveira Art Biennial Foundation (FBAC) is launching the **"New Artists Contest 2021"**, as part of the application "Cerveira Art Biennial Foundation: Contemporary Art integrated in society and in the world" (2020 - 2021 - Sustained Support - Visual Arts). Through the promotion and dissemination of contemporary artistic production, creative experimentation and exhibition activity as a means of reflection on art and visual culture, we seek to give opportunity to new creators.

Aimed at emerging national and foreign visual artists with a career spanning less than 15 years, this contest is also intended to consolidate FBAC as an attentive and active institution in the national and international artistic panorama.

The contest foresees the selection of two (2) proposals for solo exhibitions by an Advisory Committee, constituted by professionals with extensive experience in the national artistic scene.

The exhibition will take place at the Gallery's rooms of the Cerveira Biennial Museum. The deadline for applications runs until August 1, 2021, and they must be submitted via an online form.

ARTICLE 1

Applications

1. The "New Artists 2021 Contest" is open to the participation of national and foreign artists for the submission of proposals of solo exhibitions that, when duly presented in application, will be subject to the appreciation of an Advisory Committee, which will take into account the physical and material conditions for its feasibility.

2. The required documents are the following:

- a. [Registration form](#);
- b. Detailed description of the exhibition's project, clearly and objectively presenting its design, specific characteristics of the artworks, the complete assembly and dismantling plan, the necessary materials, equipment and other information the applicant deems necessary to understand the exhibition's proposal;
- c. Images of the works to be exhibited, including full identification (title, date, technique, dimensions);

- d. Artistic curriculum of all participants;
 - e. Portfolio and additional documentation (optional).
3. The portfolio and other non-mandatory documents may be consulted on the website that the applicant may indicate. Works in video or web format, please send links where they are available for online consultation. candidaturas@bienaldecerveira.pt
 4. Proposals must be sent until 11:59 PM (Lisbon time) of August 1, 2021.
 5. The result of the selection will be communicated by email and published on the FBAC website until 31 August 2021.

ARTICLE 2

Exhibition Space

1. The exhibitions will be held at the Cerveira Biennial Museum's Gallery, located at the Cerveira Cultural Forum.
2. The gallery has two interconnected rooms, with Room 1 measuring 152.5m² and Room 2 measuring 134.3m² (floor plan and photographs attached). The floor is made of polished concrete, the walls and panels are painted in gray and the lighting system consists of fluorescent lamps.
3. Interested applicants will be able to visit the space (North Entrance) during office hours of the Cerveira Art Biennial Foundation's services (From Monday to Friday, from 9 AM to 12:30 PM and from 2 PM to 5 PM) by appointment (geral@bienaldecerveira.pt).
4. During the exhibition period, the Gallery is open to the public from Tuesday to Friday, between 3 PM and 7 PM, and on Saturdays, from 10 AM to 1 PM and from 3 PM to 7PM (schedule may change due to the COVID-19).

ARTICLE 3

Selection

1. The proposals will be analysed by an Advisory Committee, constituted by professionals of acknowledged competence in the national artistic scene;
2. The submitted applications will be evaluated according to the following criteria:
 - a. Clarity, objectivity and feasibility of the proposal;
 - b. Quality of the work;
 - c. Insertion of the proposal into the contemporary artistic field.
3. The Advisory Committee will also define a supplementary list with 3

(three) proposals for a possible withdrawal or impossibility to carry out any of the selected proposals.

ARTICLE 4

Assigned Value

1. Each selected proposal will receive a cost allowance for the production of the exhibitions in the amount of 1626.02€ (one thousand six hundred and twenty-six euros and two cents) - including taxes set out in current legislation, if this is legally owed.

ARTICLE 5

Sale of Works

1. All artworks may be available for sale if the artist so decides, going to the organization a percentage of 30%.

ARTICLE 6

Rights and Duties

1. Of the Cerveira Art Biennial Foundation, P.F:
 - a. Assembly and dismantling support of the exhibition;
 - b. Maintenance and surveillance of the Gallery during the exhibition period;
 - c. Disclosure of the exhibition in the way it deems most convenient;
 - d. Allocation of the allowance.
2. Of the applicant:
 - a. Provide packaging, insurance (not mandatory), shipping and return of the works, as well as specific materials and equipment not available at FBAC;
 - b. Be responsible for any damage or loss of the artwork during transportation, assembly and dismantling;
 - c. Deliver and remove the works on the site and according to the schedule defined by FBAC;
 - d. Provide digital high resolution images of the artworks, texts and their rights for dissemination and use by the Educational Service, within the timeframe defined by the FBAC;
 - e. FBAC recommends that the authors of the proposals be present during the assembly and disassembly of the exhibitions. If this is not possible, they must provide detailed instructions within the period defined by FBAC.

ARTICLE 7

General Provisions

1. FBAC will reject proposals that do not comply with the terms of this Contest, whose registration implies automatic and full acceptance of all the established conditions;
2. Any alteration requested by the applicant after the opening of the exhibition must be analysed by the FBAC;
3. The omitted cases shall be analysed and resolved by FBAC.

ARTICLE 8

Implementation Date

1. This document shall enter into force on the day of its publication, on the website of the Cerveira Art Biennial Foundation, P.F.

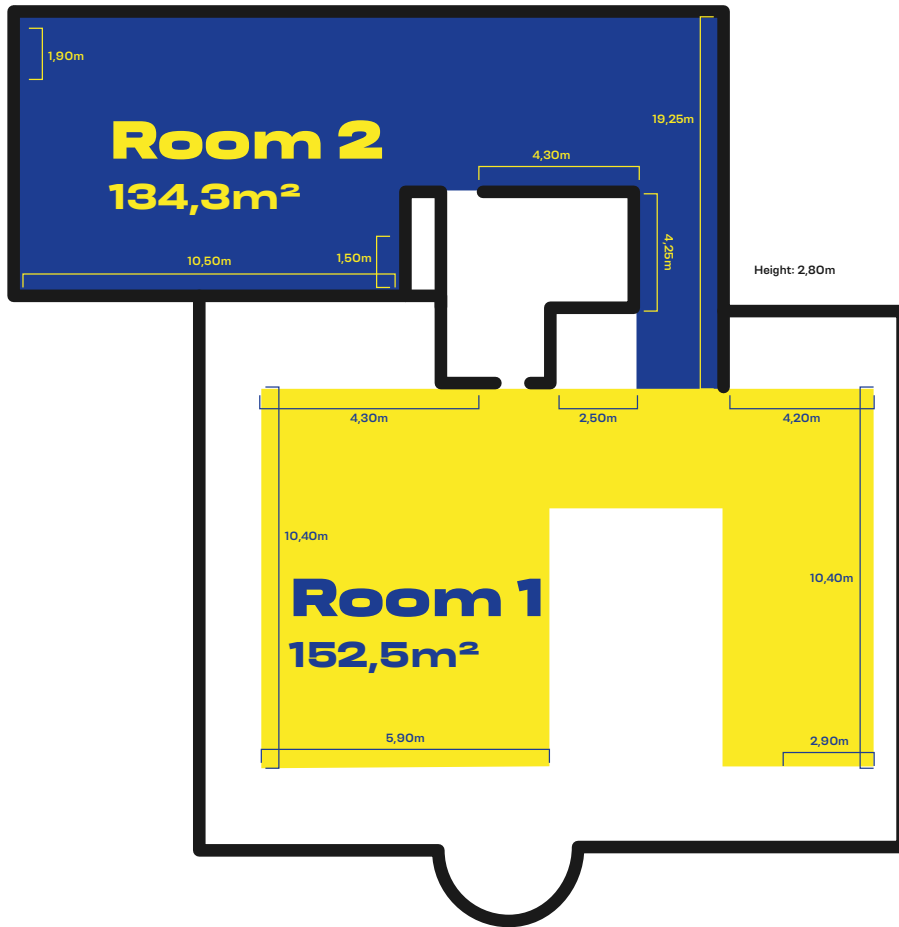

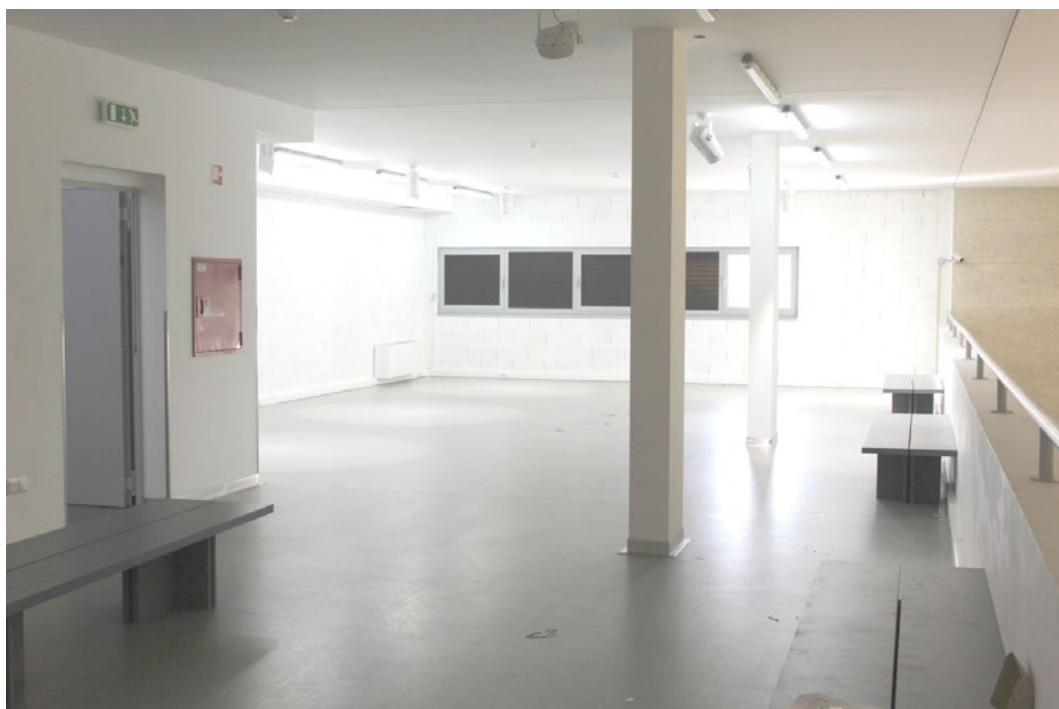
